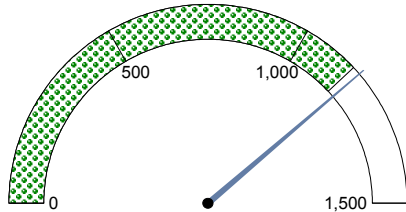

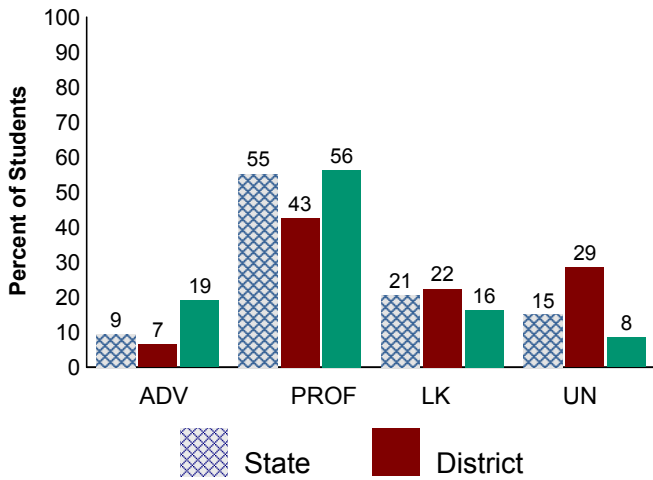

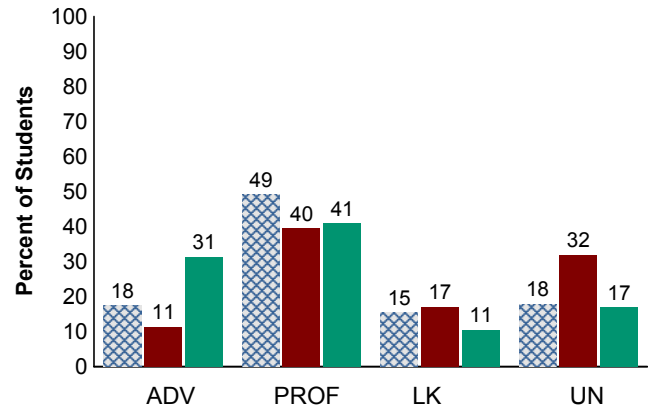
**State and District Reading Results**

All Students Tested



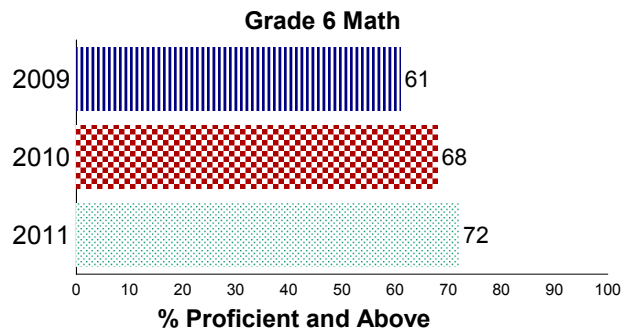
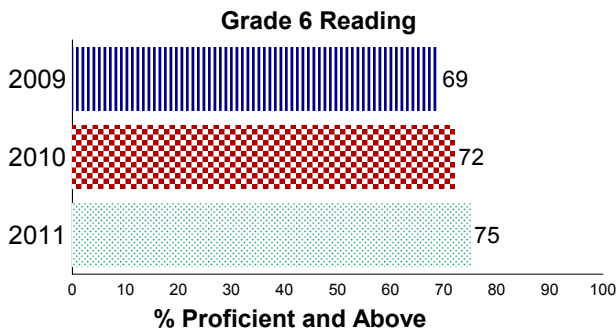

All Students Tested



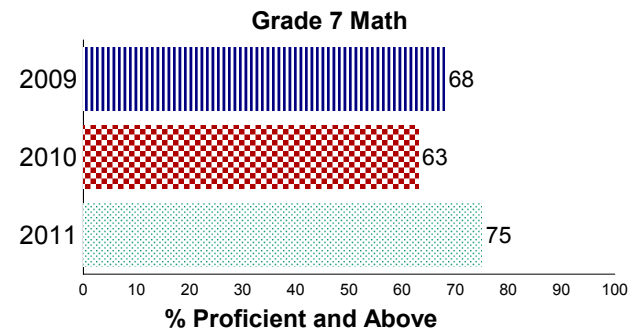
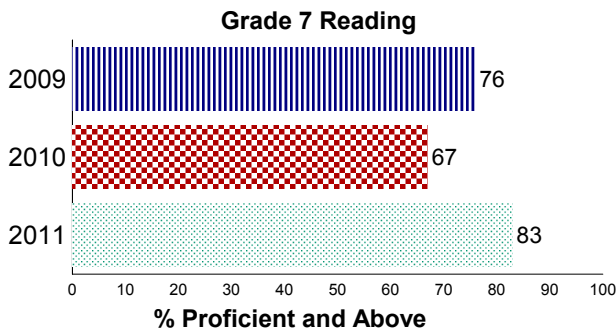

All Students Tested



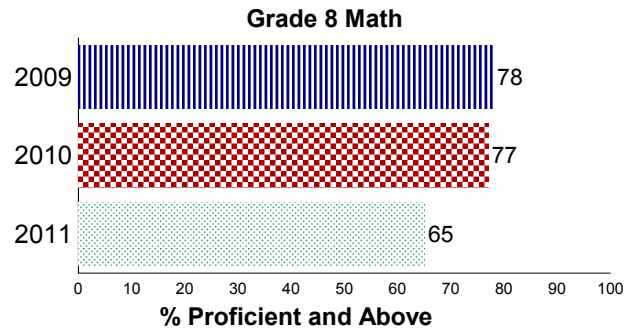
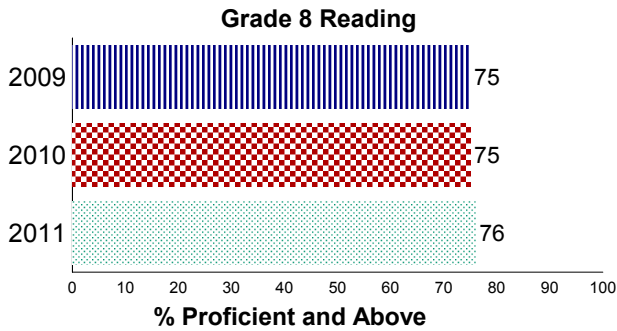
**State and District Math Results**
