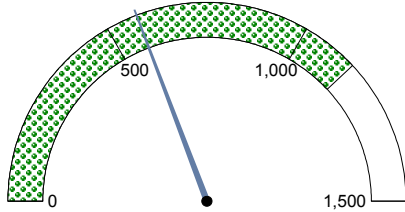

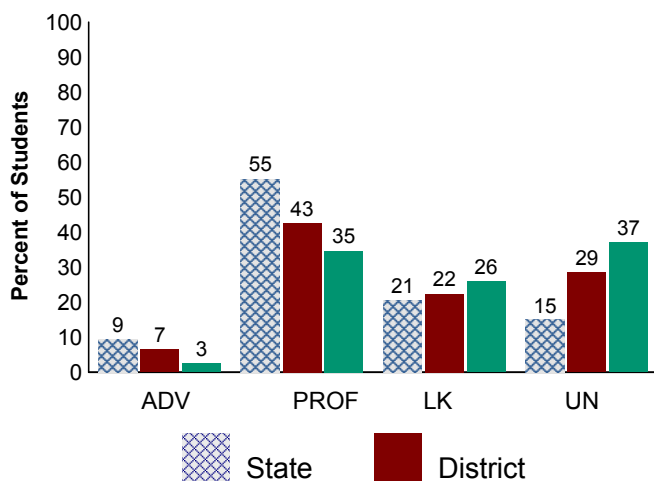

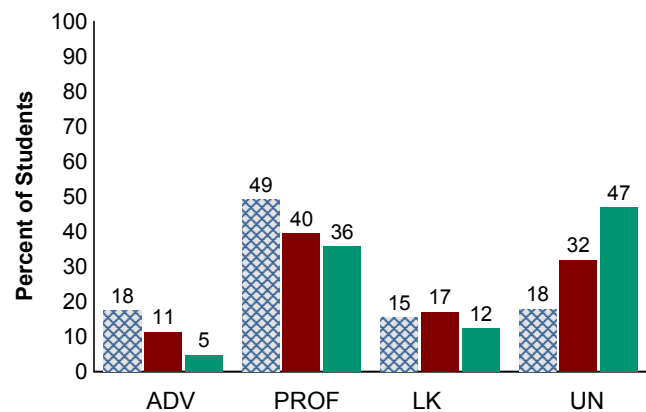
## State and District Reading Results

All Students Tested



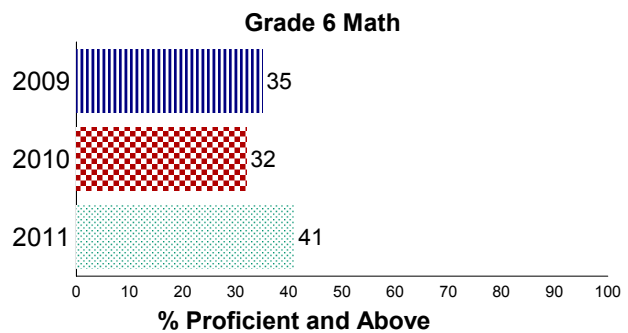
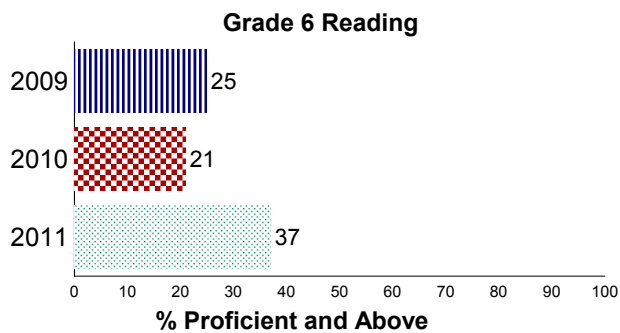
## State and District Math Results

**State and District Math Results**

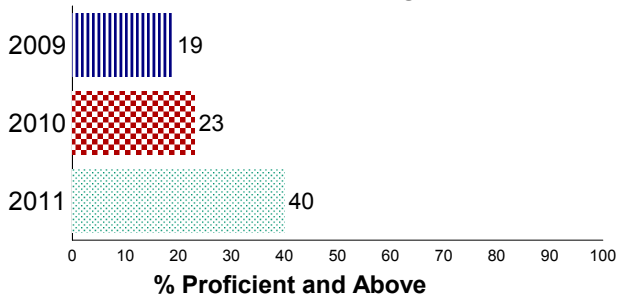

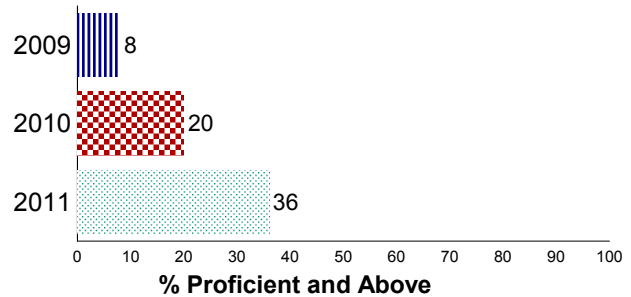
