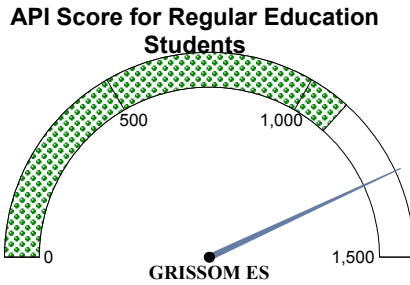


**GRISSOM ES****No Child Left Behind Act Annual Report Card 2009-2010****Academic Performance Index (API) and Accountability Data**

The API is a numeric score that measures school and district performance based on a variety of educational indicators. 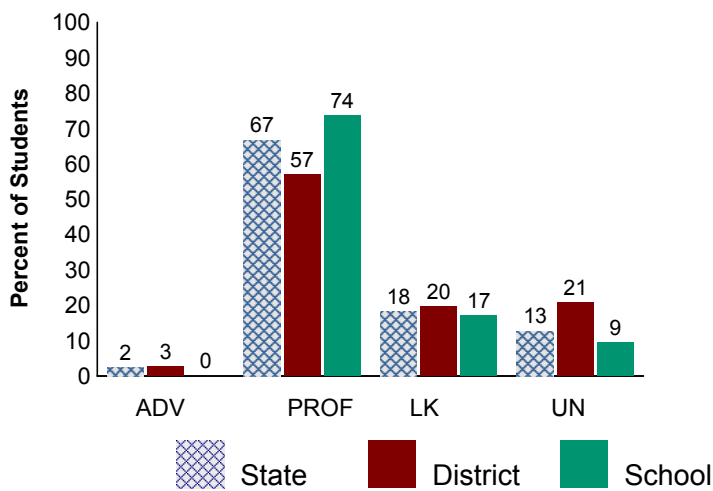

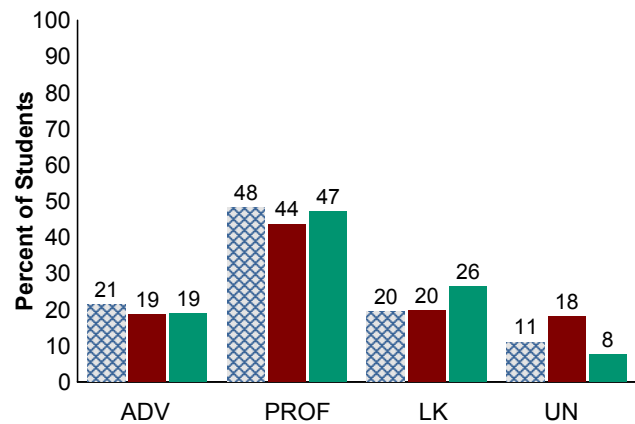
**State, District and School Reading Results**

All Students Tested



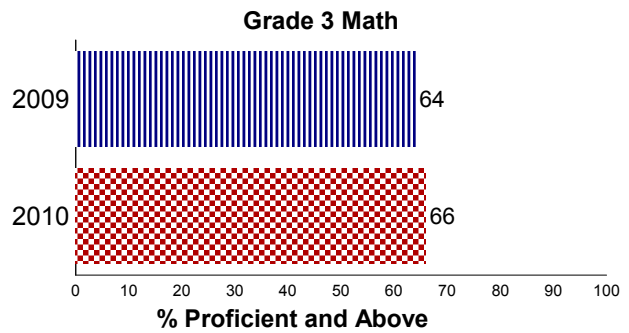
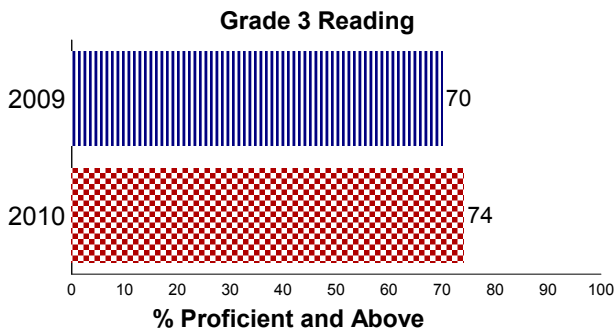

All Students Tested



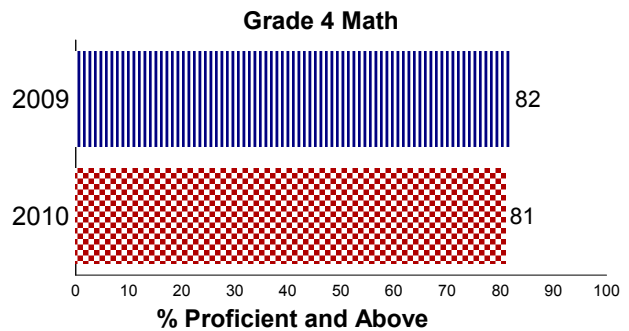
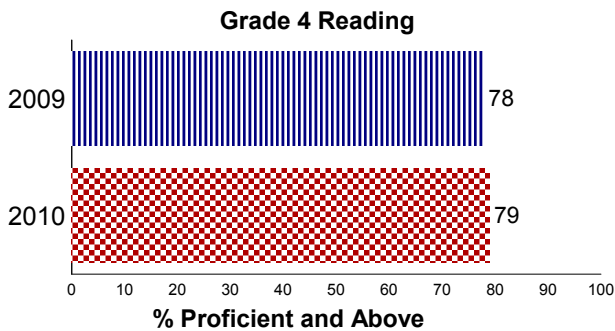

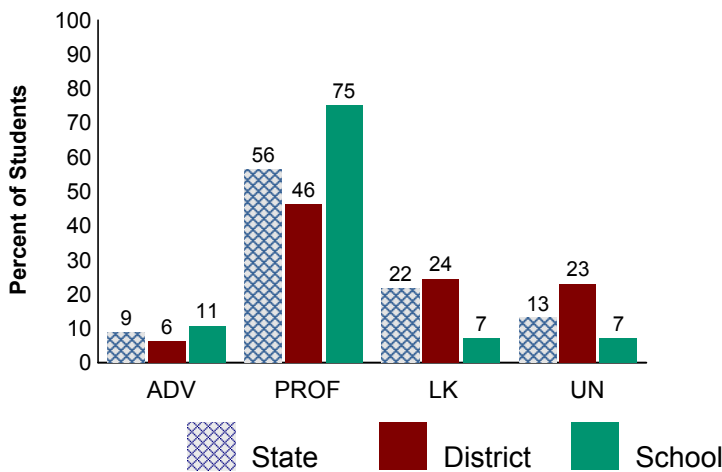

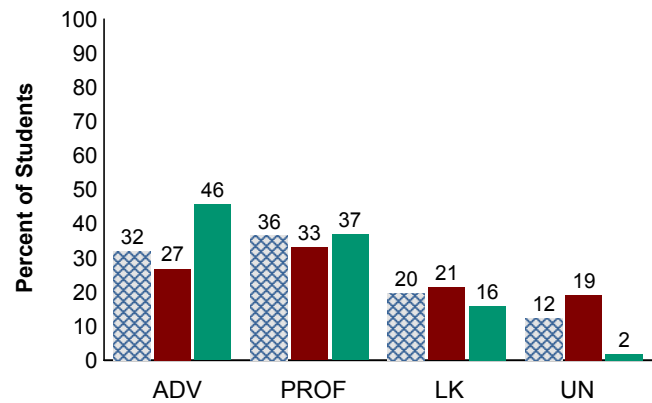

**State, District and School Math Results**

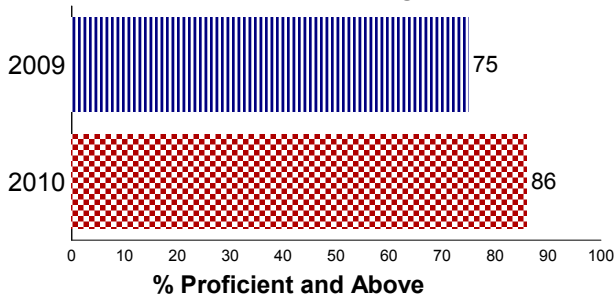

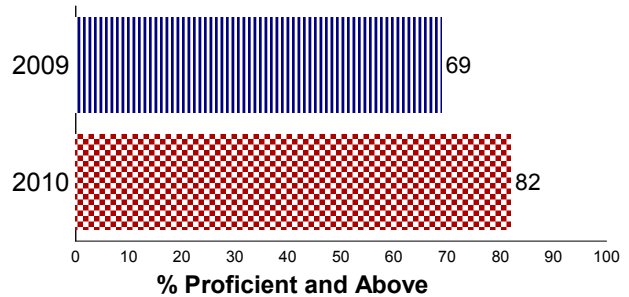
