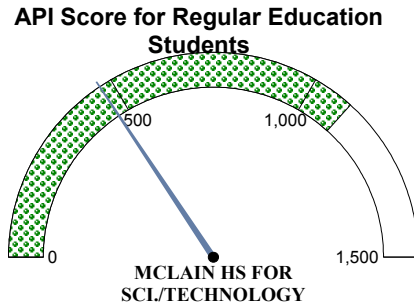

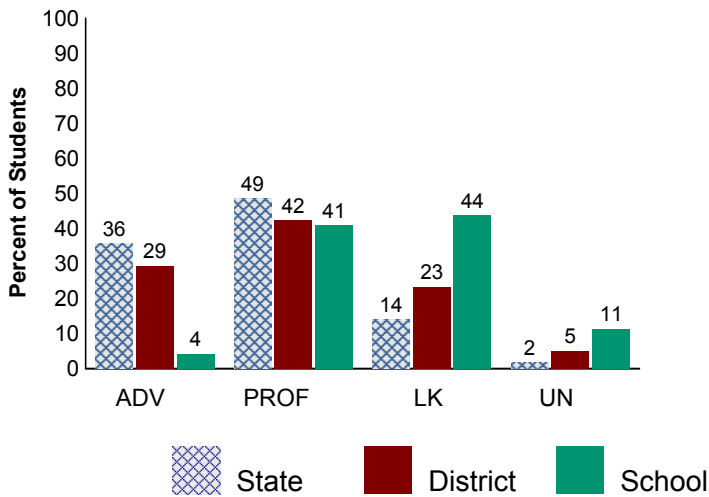

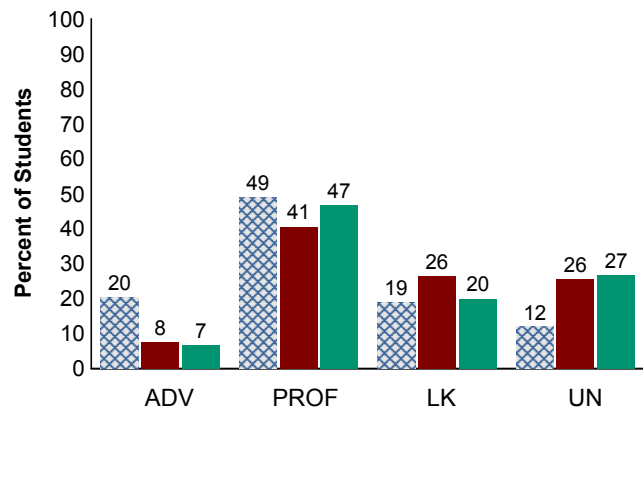
**State, District and School English II Results**

All Students Tested



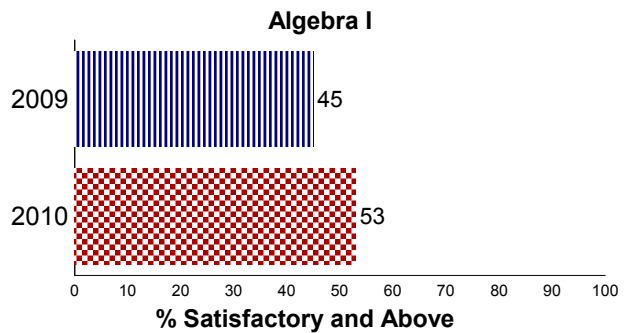
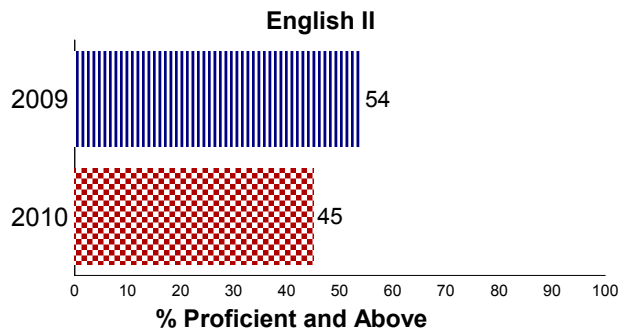
**State, District and School Algebra I Results**
